# PRESENTATION - LOS ANGELES / ORANGE COUNTY REGIONAL CONSORTIUM (LAOCRC)

LAOCRC **Presentation** 

Michael Sacoto, K-14 Technical Assistant Provider, provided an overview of LAOCRC which is the second biggest consortium in the state. LAOCRC ensures a high sense of collaboration between the community colleges and the K12 LEAs. Nicole Berkman is one of four K12 Pathway Coordinators and has reign over the southern part of Orange County. Some responsibilities of the K12 Pathway Coordinators include regional needs assessment and leadership, professional development to ensure K12 project leads have the regional leadership and technical assistance needed, coordinate collaboration and ensure community colleges are engaged and involved, and K12 SWP program management.

The work of CCA is not duplicated in other regions and many of the best practices and model programs taking place at CCA will serve as a blue print to implement in other areas of Orange County.

CCA and the two Districts served are deeply embedded and CCA courses are within the master schedule, 100% of CCA courses meet UC a-q requirements and 30%-35% of CCA students realize their articulated course credit due to the strong partnership with Saddleback College and use of the CATEMA system. Instructors, counselors and partners guide students through the articulation process. Only 2% of students region wide realize their articulated course credit because it is the student and parent who have to navigate the articulation process.

CCA model programs include dual enrollment with Saddleback College in various classes due to the strong relationship between Saddleback College, Patricia Romo and Nicole Berkman. Part of the Strong Workforce is to build a strong work-based learning opportunity. CCA's partnership with Kaiser Permanente and Waldorf Astoria provide students with learning opportunities through visits at these sites 2-3 days a week during the school schedule.
